Case Complaint Summary

This complaint is filed by PAHL & McCAY, a Professional Law Corporation, against defendants DAVID LAWVER, PALLADIUM DEVELOPMENT LLC, and DOES 1 through 20. The complaint alleges breach of contract, quantum meruit, account stated, and indebtedness assumpsit. PAHL & McCAY is a California professional corporation, and the defendants are individuals and a Delaware limited liability company.

According to the complaint, PAHL & McCAY provided legal services to LAWVER starting from March 5, 2018, and continued to provide services jointly to LAWVER and PALLADIUM. Invoices were issued to the defendants for services rendered, and a termination of representation letter was sent to the defendants on May 23, 2023. The outstanding balance due to PAHL &

McCAY is \$40,255.10.

The complaint seeks judgment against the defendants for the outstanding balance, service charges, late fees, attorneys' fees, and interest. It also requests costs of the suit and any other relief deemed just and proper by the court.

Note: No dollar amounts other than the outstanding balance of \$40,255.10 are mentioned in the complaint.
